

# Spring 2017 Detention Center Continuing Education Training Registration Form

This form should be completed by the Jail Administrator or their representative.

Arkansas Tech University-Ozark Campus is now offering online continuing education training approved by CLEST (Arkansas Commission on Law Enforcement Standards & Training) for Arkansas detention centers and detention staff. This online course is designed and intended to satisfy the 16 hours of continuing education required of Arkansas Criminal Detention Facility Standards. The course will be offered on a semester basis for the Fall and Spring, coinciding with the Arkansas Tech University-Ozark Campus academic calendar. The course will consist of 16 clock hours involving videos, PowerPoint presentations, and documents for reading. Topics this year include Ethics, Inmates with Special Needs, Workplace Stress, and Effective Report Writing.

The course must meet a minimum of 13 participants in order to be opened. Each detention facility does not need to register 13 participants, but we must have that total across all detention facilities in order to open the course. Once the minimum is reached, the online course will open and the contact person listed on this form will be notified. Once this registration form is processed by ATU-Ozark and we have 13 participants, the participants listed will be invited to the class via email by instructor Chris Rambo and coursesites.com. The course will be conducted through Coursesites.com .

Arkansas Tech University-Ozark Campus provides access to the material but it is up to the participant and the detention center to ensure the participant views the material provided in the course.

Upon completion of all modules within the online training, Arkansas Tech University-Ozark Campus will print and mail certificates showing the participant has completed the 16 hours of continuing education jailer training.
